

Glider rental contract

between :

1. OWNER'S responsibilities

The OWNER will provide the GLIDER with a valid ARC, full instrumentation in meters +

- xxxxx
- Flarm
- a third party liability insurance (3rd party) according to IGC regulations
- and an hull all risks and war risks insurance policy in place at all times for the GLIDER.

The OWNER will provide the documentation required to be carried aboard the GLIDER and a copy of insurance certificate (specifying the guarantees and their limit and the deductible) prior to the signature of this contract.

Prior the start of the rental, the RENTER will ensure that the GLIDER is free of damage and that all equipment is present. Any damage or missing equipment shall be notified to the OWNER immediately before the first flight.

The OWNER provides with the GLIDER:

- full papers
- xxx Trailer for ASG 29 with insurance (third party and hull)

The glider and his trailer will be delivered in Montluçon - Guéret by the OWNER.

2. RENTER'S responsibilities

The RENTER certifies that the pilot(s) using the GLIDER has/have a valid glider pilot's license and medical certificate (ICAO/EASA Class 2) and has at least 1000 flight hours as glider pilot.

The RENTER shall deliver the GLIDER back to the OWNER on the last day of rental, the GLIDER shall be cleaned, be in the trailer, and all equipment shall be in the trailer. All documentation shall be handed back to the OWNER.

3. Insurances

A 3rd party liability insurance policy as required by IGC must be taken out by the OWNER and in place in respect of the Glider. The police will be kept and handed over with the glider documentation.

The OWNER must also take out a "Hull all risks insurance" for the GLIDER which covers the full price of the glider and the instruments. The insurance taken out by the OWNER has an excess insurance cost (deductible) of xxxxxx \$. The RENTER shall pay damages up to the

amount of the deductible not covered by the OWNERS's insurers.

The trailer have a "comprehensive" insurance.

4. Payment

The rental fee is **xxx€** regarding glider + trailer + delivery in **xxx** for the whole renting period.

The RENTER shall pay the rental in three parts:

- **xxx€** after signature of the contract by the parties,
- **xxx€** by **xxx** 2021,
- **xxx€** after delivery of the glider, inspection of the glider, providing that everything is in order, and before the first flight.

In case of withdrawal, the amount already paid will be kept by the owner, except if he finds another renter.

Should the glider(s) not be delivered or in order after inspection, the owner hereby agrees that he will proceed to the refund of the payment made at the signature of this contract.
